#### XIV. New Business-

Question about pandemic, school closure raised. No information and hard to predict at the moment.

Question about N19 and 3 layer masks raised. Angela mentioned that the Ministry has send masks to schools, now we have run out of those and District is supplying the schools with disposable masks. First Aid attendants all got supplied with face shields.

Question about communication was raised CUPE website is been down for a while and will be up and running soon.

Question about our collective agreement, cross reference to know what was changed in previous agreement.

Angela mentioned Motion to close SIMS. Cynthia Marshall and Angela Thomas met with Scott Benwell and D'Arcy Deacon. After the Board meeting in February they will motion to close SIMS and will have a final vote. The Layoff and Recall committee will leap into action following this decision. We anticipate clerical and BSW to be affected. Sue-Anne Donaldson expressed some concerns and mentioned that the safety and environmental space does impact the learning of a student. She was encouraged to bring this feedback at the staff meeting on December 8.

Issue about trade market adjustments not having enough EA subs. Lack of qualify EAs. district has committed to create a program of in-service training offering courses for EA to get fully qualify. The shortage is across the province not just for EAs but also Bus Drivers.

The trigger for a trade market adjustment is recruitment and retention. We are moving into bargaining next year and this is something that is brought up across the province. We will put together a bargaining committee in June.

Bus driver's concern for driving with kids who don't believe COVID is real, also how to deal with sick kids on the bus. Angela mentioned that any sign of a sick student needs to be reported immediately and do not let into the bus.
